and

Institute of Radioelectronics and Informational Technologies of Federal State Autonomous Educational Institution of Higher Professional Education "Ural Federal University named after the first President of Russia B.N. Yeltsin", the Russian Federation, Tax Corporate Identification Number 6660003190, represented by Professor Sergey N. Shabunin who shall sign as the Director of the Institute to be duly mandated for the act to be referred in the following as IRIT - RtF, have concluded the present agreement on the following:

- 1.1. The parties are starting from the fact that it is in the interests of each of them to join the operations in the area of science and education between FCT UNL and ITIT RtF.
- 1.2. With this view the parties will consider the possibilities for:

- -Exchange of training and methodical literature, teaching plans and curricula;
- -Arrangement and conducting of joint seminars, conferences, exhibitions on the subjects of cooperation;
- -Carrying out joint scientific research work in accordance with coordinated programs;
- -Preparation, realization and publishing the results of possible mutual researches in the periodicals by the parties, as well as in Internet;
- -Using the possibilities of remote learning, including teaching specialized disciplines in English;
- Exchange of educational videos;
- -Professional development of faculty through learning educational and informational technologies, management in education and other subjects of mutual interest;
- -Organizing the marketing of medical devices developed by the parties.
- 1.3. The parties in this agreement recognize the importance of creating a diverse and welcoming environment in science and education, as such, this agreement will allow for equal participation by all individuals, regardless of race/ethnicity, sexuality, gender, religion, ability or any other difference.
- 1.4. The present agreement imposes no financial or legal obligations. The parties attract

financial means from various funds and programs.

1.5. The present agreement is valid for the period of time of three years until March 6, 2018, and could be prolonged further if the parties have no restrictions.
